#### **WV ASHRAE School Benchmarking Project Picks Up Speed:**

A team of 3 Chapter Members, headed up by Art Hallstrom (<a href="mailto:ahallstrom@wvashrae.org">ahallstrom@wvashrae.org</a>), are conducting a project for the WV State Energy Office to Energy Benchmark all K-12 WV Public Schools. Benchmarking involves determining the annual School Energy Use Intensity (EUI) and Energy Star Score. Knowing this information allows a school to measure their energy performance over time and against other schools in WV and the US. Thanks to CMTA and ZDS several WV Schools have already received Energy Star 2018 certification.

This program is free with no obligation. There is no commercial connection between the ASHRAE team and building owners. The ASHRAE team provides technical assistance, education, and with the State Energy Office – Recognition of top performers. ASHRAE bEQ is also promoted as part of the program. The Project Administrator is the WV ASHRAE Chapter GAC Chair, David Cotton, P.E.

This multi-year benchmarking project kicked off at the West Virginia Association of School Facility Administrators (WVASFA) meeting in July 2019. To date, the following school districts have benchmarked all or most of their buildings: Barbour, Berkeley, Braxton, Cabell, Calhoun, Grant, Kanawha, Monongalia, Morgan, Ohio and Tyler.

The average EUI and Energy Star District Scores per square foot will be released shortly to WV ASHRAE Chapter Members. Project team member Michael Hallstrom is traveled WV during November and is continuing through December to visit the 18 additional School Districts not currently participating in the State Energy Office Benchmarking Program with the intent of joining the program.

Once the K-12 public schools are energy benchmarked, the next step will be to assist local governments in benchmarking other government owned buildings.

Several utilities like AEP, First Energy and Mountaineer Gas are participating by provide digital files of building energy usage into the Energy Star Portfolio Manager. This step makes it easy to keep the benchmarking metrics current and up to date.

#### Importance of EUI in building design/construction/operation

There is a growing awareness of energy use in buildings. The metric often used is EUI. Every building has one. It is like MPG for a car or truck. ASHRAE provides guidance on how to calculate this value and Energy Star has metrics on average energy use by building types in each climate zone. The WV School Building Authority is looking at setting a 40 EUI target for new K-12 schools which is below the 2018 national average of 48, but higher than some of the top net zero ready schools that have an EUI around 21. ASHRAE has published Advanced Energy Design Guides – the newest is for zero energy office buildings. (ASHRAE.org/aedg). ASHRAE just closed the 60% complete **Peer Review of Advanced Energy Design Guide for Multifamily Buildings – Achieving Zero Energy**. It should be out early next year. All chapter members should be familiar with energy benchmarking which can include the ASHRAE bEQ rating. More info can be found at www.ashrae.org.

WV has joined the Northeast Energy Efficiency Partnership (NEEP). It consists of states in the Northeastern US and is focused on sharing and promoting building energy conservation. 
