#### **Conservation Standards for Manufactured Housing**

The U.S. Department of Energy published a supplemental notice of proposed rulemaking (SNOPR) to establish energy conservation standards for manufactured housing pursuant to the Energy Independence and Security Act of 2007. This proposal presents two potential approaches:

- Providing a set of "tiered" standards based on the manufacturer's retail list
  price for the manufactured home that would apply the 2021 IECC based
  standards to manufactured homes with a retail list price of over \$55,000.
   Manufactured homes with a retail list price of \$55,000 and below would be
  subject to less stringent building thermal envelope requirements.
- The alternative approach would apply standards based on the 2021 DOEo all manufactured homes, with no exceptions for building thermal envelope requirements based on the manufacturer's retail list price.
