The Nov 16 WV ASHRAE Chapter Meeting is a free tour of the New Herbert Hoover High School in Kanawha County. The building is nearing construction completion (~80%). Harper Engineering provided the MEP design for the project. Key building features are vertical geothermal water source heat pumps for each classroom located in a mechanical closet, DOAS (ERV) rooftops connected to the geothermal loop, and LED lighting on occupancy sensors.

The West Virginia Society for Healthcare Engineering (WVSHE) will join us. Darian Swiger with WVU Medicine is coordinating their participation.

Please arrive around 11:45 am. Bring a hard hat for this tour and wear appropriate shoes/boots for a construction site. We will have some loaner hard hats available.

At 12:00 the ASHRAE group has tour the school, while the WVSHE group will have a business meeting with lunch. At 12:30 WVSHE will tour the school, while the ASHRAE group has lunch and a chapter meeting.

Virginia's Energy Future and how recently passed federal laws will impact the future of energy in the state.

It was also a time where three prominent people were recognized for their service to West Virginia. Dr Bhaskaran Gopalakrishnan, Dr. Kenneth Means, and Arthur Hallstrom were proclaimed by West Virginia Governor Jim Justice as Distinguished Mountaineers. Their countless, dedicated hours of service to the state have made a lasting impact that continues to benefit and shape students, professionals, and businesses and they express their heartfelt gratitude to these gentlemen. Congratulations to these three professionals!

Art Hallstrom had the following to say about the event:

"Many ASHRAE members attended this recent event sponsored by WV Energy Office, Marshall Energy Education Center, and WV ASHRAE. WV ASHRAE members attending included Chapter President Garrett Weaver, VP Terry Hollandsworth, Karen Lasure, Dr Ken Means, Jeffrey Brown, Art Hallstrom, Xavier Walter, Margie Phillips, and many others. This was a well attended event with about 160 attendees.

A presentation by WV NETL covered how they are working on how to use hydrogen as an energy source. NEEP, the Northeast Regional Partnership, covered their support for WV and the State Energy Office. A number of electric vehicles were on display. A Rivan truck, Electric Bus, Electric Semi. Tesla Car, and a fast charger station showed these new technologies. I found the discussion on how to charge the school buses very interesting. It is more the plug power. Bus driver time is also a factor.

The Mayor of Summersville covered the hydroelectric dam they own. Turns out they could get a lot more output if the Corp of Engineers would let the pool height vary based on need versus a fixed date change. He is trying to get it changed and sounds like he will continue."
